The competent authority, after considering the report, has been pleased to grant temporary affiliation for the session **2018-19** for the existing courses with earlier sanctioned intake, i.e., B. Tech. in CSE (60 seats), ECE (60 seats), ME (120 seats), CE (60 seats), EE (60 seats) and BBA (60 seats), BCA (60 seats), M. Tech. CSE (18 seats) and M. Tech. ME (18 seats) for the session 2018-19 **subject to fulfillment of the deficiencies pointed out by the inspection committee. A photocopy of the inspection report dated 04.09.2018 is enclosed herewith for necessary compliance. The compliance report (alongwith all supporting documents / proofs such as bills of materials / items procured, photographs / maps of facilities created, etc.) be submitted within (01) one month.**

The above provisional affiliation for the existing UG/PG courses with earlier sanctioned intake is further subject to the condition that the institute will make full compliance of the provisions laid down in the Statute, Ordinance and the decisions taken by this University from time to time.
